BMO Move-In Information

A staged move in approach is in full effect through the BMO Centre logistics management system, Voyage Control. You must book your specific time to gain access to the BMO Loading Dock Apron.

- 1. Go to the BMO Centre portal at http://calgarystampede.voyagecontrol.com/
- Click the LOG IN/SIGN UP button to create an account. If you have an existing account from previous years or other venues that also use Voyage Control you can use the same login information
 - User Type = Exhibitor
 - Booking Code = TBD (will be available Feb 1, 2026)
- 3. Select a time for your load in, available times include:
 - Thursday April 30, 1:00 pm to 6:00 pm
 - Friday May 1, 9:00 am to 2:00 pm

How Do Sample Tokens Work?

- Both festivals are strictly sampling events.
- All samples must be exchanged for sample tokens and no cash sales are permitted.
- Maximum Sample Sizes:
- Beer, Cider, RTDs 4 ounces
- Spirits − ½ ounce
- Sample tokens are \$1.00 each.
- Minimum of 2 tokens per sample.
- ABF will collect the sample tokens from vendors at the end of each evening.
- You will receive \$0.50 per sample token collected.
- A breakdown sheet of sample tokens collected per session and rebate cheques will be mailed to each sampling vendor no later than two weeks following the completion of both festivals.

What Volume of Product Do Vendors Serve?

BEVERAGE - number of samples poured per session according to the 2024 festivals:

- Average Number of Samples Per Session = 600
- 1800 samples in total per festival
- Based on assumption that all samples were 2 sample tokens each Note this is an average! Some vendors will serve more, and others will serve less.

FOOD - number of samples poured per session according to the 2024 festivals:

- Average Number of Samples Per Session = 500
- 1500 samples in total per festival
- Based on assumption that all samples were 3 sample tokens each

Note – this is an average! Some vendors will serve more, and others will serve less.





How Do Vendors Order Products?

ABF is proud to have Sobeys Liquor and Safeway Liquor as our Title Sponsors and Liquor Store Partners! Below is the Order Form to complete when submitting your liquor order.

Only vendors that order products through Sobeys Liquor will have access to cold storage.

Why Should You Order Through Sobeys Liquor?

There are a lot of perks when you order through Sobeys Liquor, including:

- Your product will be featured at the On-Site Liquor Store.
- Free access to the Sobeys/Safeway Liquor reefer trailer.
- Join Sobeys program to support local.

Important Steps:

Vendors ordering through Sobeys Liquor need to complete and submit the Sobeys Liquor Order Form

- Download a copy of the <u>Sobeys Liquor Order Form</u>
- Complete the Liquor Order Form & email it to <u>beerfest@sobeys.com</u>

Return Product (post-event) – please email the email address that you placed your order with to request return. Include quantity and description as well as order code. Sobeys will assign a location once all returns have been assessed. No excess product left at venue – Absolutely <u>No Exceptions</u>

How does the Business to Business (B2B) Industry Session work?

- A unique opportunity for vendors (you) to network with key decision-makers in the liquor and hospitality industries.
- Showcase your product to owners and managers from local liquor stores and restaurants *please* have your booth ready and staffed by 4pm on Friday.
- Admission to the Industry Session will be free for owners and managers of liquor stores and restaurants.

- BMO Centre
- Friday, May 1, 2026, 4pm 5pm
- Share THIS LINK with owners and managers from your network they will receive their complimentary passes directly through Showpass!
- **Food Vendors** are <u>not</u> required to serve food, you can use this time to continue preparing for the consumer portion of the festival which begins at 5PM.

AHS – Policies + Reminders

All vendors must have hand sanitizer at their booth!

Who DOES NOT have to complete AHS Form?

- Beverage Vendors that are strictly serving alcohol

Who DOES have to complete the AHS Form?

- All Restaurant Vendors
- Beverage Vendors that are using garnishes with their samples (i.e. fresh fruit or vegetables).

Where do I find the AHS Form?

- Find a copy of the AHS form you can fill out online and then save <u>HERE</u>
- Before you complete and submit, please review the **Special Event Food Vendor Package**
- Form must be submitted prior April 1, 2026

AGLC - Policies + Reminders

- Be sure to read and understand all information forwarded to you by AGLC regarding festival participation.
- No minors allowed in the venue this includes working at booths in any capacity!
- No consuming alcohol behind your booth for any reason.
- Products cannot be "pre-mixed" all cocktail samples must be prepared on-site.
- All samples must be exchanged for sample tokens no cash sales are permitted
- Maximum Sample Sizes:
 - Beer, Cider, RTDs 4 ounces
 - Spirits ½ ounce
- Sample tokens are \$1.00 each
- Minimum of 2 tokens per sample

*Proserve

- All vendors serving alcohol must have Proserve
- All staff at beverage booths need to have their Proserve cards with them.
- Vendor Check-In All beverage vendor staff will need to show their Proserve at the entry point in order to receive their exhibitor wristbands and enter the venue.

Restaurants are not permitted to serve or collect tokens for alcoholic samples at the festival



Fire Department – Policies + Reminders

Tents/Canopies

- ALL tents and canopies must be approved for indoor use
- ALL canopies must have a tag (attached to the canopy) clearly indicating that it is approved for indoor use and has a <u>CAN/ULC-S109</u> or <u>NFPA 705</u> rating.
- Be sure to have this confirmed prior to bringing your canopies to the festivals!
- If you bring a tent bring a smoke detector

Display Vehicles

- Must have less than ¼ of gas in the tank no exceptions!
- Gas gauge must be functional.

Be sure to read and understand the <u>Calgary Fire Department Indoor Events Guide</u> regarding festival participation.

Frequently Asked Questions

I need my product chilled - how do we do this?

- All vendors that order product through Sobeys Liquor will have access to cold storage
- There is no cold storage available for vendors that do not order their product through Sobeys Liquor for the Calgary International Beerfest.
- There will also be ice available to order onsite at the festivals (\$12 per large bag). Visit the Ice Booth at the back of the hall.

I need to rent or purchase a draught unit - how do I do this?

Are we allowed to sell merchandise at the festival?

These are sampling festivals and selling product is not permitted

Exhibitor registration will only be considered to be valid when it has been completed in full and processed by Alberta Beer Festivals Inc., including all monies to be received. 'In Full' means fully executed Exhibitor Registration Forms, and a signed & dated 'Rules and Policies' page.

CONFIRMATION

In order to ensure registration, please ensure that you have the following: Completed registration form, signed rules and policies form, as well as your final tally payment.

INDEMNIFICATION

The Calgary International Beerfest, The Edmonton Craft Beer Festival, The Banff Craft Beer Festival, and Alberta Beer Festivals Inc., Sponsors, and/or the host facility shall not be responsible for injury, loss or damage to persons, goods, equipment or decoration which occurs during the transportation of goods and/or other cause beyond the control of the organizers, who shall be in no way whatsoever liable.

RESTRICTIONS

The event organizer reserves the right to modify the layout and exhibitor spaces should the need arise. Further, it is agreed that the exhibitor will not in any way sublet booth space without consent from event organizers.
